#### **2024 PWHOA Election Information**

The 2024 PWHOA Election will take place on Tuesday, April 30, 2024, at 2405 Fen View Circle. The polls will open at 6:30 pm and close at 7:30 pm. Anyone who is waiting in line at 7:30 pm will be allowed to cast a ballot.

This year there are three board positions up for election. Three candidates contacted the PWHOA Board prior to the February 15<sup>th</sup> deadline and declared their intention to run for one of the three vacancies on the Board. The three candidates are Sam Duggan (incumbent), Jason Geist (incumbent), and Jen Pope. A brief bio of each candidate has been included with this newsletter.

Homeowners have two options to cast a ballot. They can vote in person on the day of the election, or they can submit an Absentee Ballot which is included with this newsletter. Homeowners need to ensure that they follow the instructions listed on the Absentee Ballot so that their ballot will be counted.

Homeowners can also forfeit their right to vote by signing a Proxy Ballot which would allow another homeowner to cast a ballot for the candidate(s) of the proxy holder's choice.

Absentee and Proxy Ballots were discussed in the January 2024 PWHOA Newsletter.

We encourage all homeowners to come out and vote in-person. It's a great way to put a name to a face. We look forward to seeing you.
