The PWHOA will hold its Annual Board Election on Tuesday, April 8th. Voting will take place from 6:30 to 7:30 PM at 2504 Fen View Circle. We strongly encourage all residents to participate by voting in person. If you're unable to attend, you may submit your completed absentee ballot, which is included with this newsletter.

Scott Kochaney, our current treasurer, and I are seeking re-election to the Board. Scott has served on the Board in various roles almost continually since its inception in 2006. I have served as your Secretary and President for nearly seven of the eleven years I've lived here.



This year, an important HOA rule amendment is included on the ballot. The amendment addresses the potential issue of Prairie Woods residences being used as "party" houses through short-term rentals on platforms such as Airbnb, HomeAway, VRBO, and others.

You might wonder why this amendment is being proposed, especially since this hasn't been a concern in the past. The answer is simple: the HOA Board voted to include this proposal on the ballot as a proactive measure to ensure it never becomes a problem. The proposed wording, reviewed and recommended by our HOA attorneys, strikes a balance between preserving the community's stability and respecting homeowners' rights.

To be clear, this amendment does not restrict traditional rentals. Instead, it introduces specific restrictions aimed at safeguarding the neighborhood we all cherish. Please take the time to vote on this important issue—your input is vital to maintaining the peace and stability we value in Prairie Woods.

HOA Meetings to Return to the Neighborhood
